Announcing our new TAX PROTECTION PROGRAM (TPP)

(Supersedes the "Worry-Free" Program)

For an additional payment of \$149, we offer you the following new TPP service for the 2014 tax returns, which includes the following:

- Unlimited number of copies and/or distributions to third parties whom you designate for your 2014 taxes (*NOTE: your written permission is required for third party distributions*).
- Preparation of all amended returns, if necessary, for your 2014 taxes.
- Responses to all notices from IRS & other government agencies for your 2014 taxes.
- Audit representation before IRS & other government agencies for your 2014 taxes.
- Appeals representation before IRS & other government agencies for your 2014 taxes.
- Support for any related court cases going beyond notices/audits/appeals concerning IRS & other government agencies for your 2014 taxes (we are not lawyers, so we cannot represent you in court. However, we will support the lawyers who may be handling your case with documents, tax research, and other necessary steps to resolve your case – however, please see **additional criteria** below for a special exception regarding court cases within our TPP.)

Additional criteria for the TPP service:

- TPP APPLIES ONLY TO 2014 INDIVIDUAL INCOME TAX RETURNS.
- TPP is available only to clients whose 2014 tax returns were prepared by DS CPA INC.
- For court cases, we must charge a rate of \$75/hr, which is a reduction from our standard \$150/hr.
- The firm reserves the right to offer TPP to selected clients at our discretion.

PLEASE NOTE: IF YOU DO NOT RETURN THE FORM BY THE APPROPRIATE DATE WITH THE \$149 PAYMENT, YOU WILL IN EFFECT HAVE DECLINED TO ENROLL IN THE PROGRAM. WE ALSO WILL ASSUME YOU ARE AWARE OF THE RATES FOR ADDITIONAL SERVICES PER THE SUPPLEMENTAL NOTICE.*

NO, I DECLINE TO ENROLL IN THE TPP. → By declining, I understand that I WILL be charged the related rates at the time of service for the following: 1.) copies of tax returns and/or distributions to third parties (written permission needed) - up to \$25/each time; 2.) amended returns - \$95-\$175 each amendment; 3.) consultations, responses, and representations involving IRS & other government agencies ranging from notices to audits to appeals to court cases - \$150/hr.
